### Highlights

- The Ohio Department of Transportation would incur costs of approximately \$350 to \$400 per set of signs to produce and install signs for most of the 36 designated memorial highways and bridges in the bill. In some cases, however, municipalities would incur costs for installing the signs.

### Detailed Analysis

The bill designates 36 new memorial highways and bridges on portions of various interstate highways, U.S. routes, state routes, and other roads throughout Ohio. Overall, the Ohio Department of Transportation (ODOT) would incur costs of approximately \$350 to \$400 per set of signs to produce and install signs for most of the designated memorial highways in the bill. Once a set of signs is installed, there are typically no maintenance costs unless the signs are damaged. Signs are usually in need of replacement every 12 to 15 years.

The cost of signage to mark the portion of a highway designated as a memorial is paid either entirely by ODOT or shared between ODOT and the municipal corporation through which the roadway passes. ODOT pays for all of the signage production costs. However, the installation costs may be borne by municipalities, depending on where the designated portion of highway begins and ends. ODOT pays installation costs for signs to be located outside of municipal boundaries, as well as the signs on all interstate routes. If a memorial highway begins or ends inside of a municipal corporation, then the city or village is responsible for installing the signage within their jurisdiction. In cases where only a portion of a designated memorial highway resides in a municipal corporation, ODOT and the city or village may share the installation costs. The table below summarizes these memorial designations in the order that they appear in the bill, including the location of the highway and the entity responsible for paying signage installation costs.

## Other changes

The bill allows the Catawba Island Township board of trustees to erect auxiliary markers in conjunction with the designation of the Catawba Island Township Veterans Memorial Highway in Ottawa County. These markers would display the names of any U.S. military veterans approved by the board of trustees, but must include (1) Private First Class William E. Galloway, and (2) SP4 James M. Davenport. The signs must be approved by ODOT. The Catawba Island Township board of trustees may also alternate these approved auxiliary markers on a periodic basis. Any costs to the township relating to these signs are permissive.

The bill also modifies the name of the Marine PFC Jacob Spann Memorial Highway to reflect his posthumous promotion to LCpl Jacob Spann. There is no fiscal impact related to this change. The bill also modifies the locations of three other memorial highways located in Logan County: (1) the Army Staff Sgt. Dennis J. Hansen Memorial Highway, (2) the Army National Guard Sgt. Jeremy M. Hodge Memorial Highway, and (3) the Marine Gunnery Sgt. David S. Spicer Memorial Highway. These location changes do not alter what entity is ultimately responsible for erecting and maintaining these signs, and therefore these changes have no fiscal effect.
