### Highlights

- The bill reappropriates approximately \$2.09 billion in capital funds for the FY 2023-FY 2024 biennium. This amount represents an estimate of available moneys on July 1, 2022. Generally, the actual reappropriations will be equal to the actual moneys available on July 1, 2022.

### Detailed Analysis

#### Capital reappropriations for the FY 2023-FY 2024 biennium

The bill reappropriates approximately \$2.09 billion in capital funds for the FY 2023-FY 2024 biennium. This amount represents an estimate of available moneys on July 1, 2022. Generally, the actual reappropriations will be equal to the actual moneys available on July 1, 2022. These capital reappropriations are summarized in the two tables below. Table 1 presents the estimated amounts by fund. Table 2 presents the estimated amounts by fund and agency.

## **Repurposing of FY 2016-FY 2017 appropriation for SOC**

The bill repurposes appropriations from Fund 5JC0 line item 235620, Regional Partnership and Training Center, given to Southern State Community College (SOC) in the FY 2016-FY 2017 biennium to permit SOC to use the appropriation for technical training offered within its service region of Adams, Brown, Clinton, Fayette, and Highland counties. Originally, line item 235620 was to be used by SOC, Ohio University Southern in Ironton, Shawnee State University, and the University of Rio Grande, to establish the Higher Education Regional Partnership and Training Center at the Point Industrial Park to bring necessary technical degree and training programs to Lawrence County and the surrounding region.
