### Highlights

#### Capital appropriations and reappropriations

- The bill makes capital appropriations totaling \$3.51 billion for the FY 2025-FY 2026 biennium. Of this amount, \$3.23 billion is supported by debt and \$0.28 billion is supported by cash.
- The bill also reappropriates approximately \$1.98 billion in capital funds for the FY 2025-FY 2026 biennium. This amount represents an estimate of available moneys on July 1, 2024. Generally, the actual reappropriations will be equal to the actual moneys available on July 1, 2024.

#### One Time Strategic Community Investments appropriations

- The bill appropriates \$717.8 million in FY 2025 from Fund 5AY1 line item 042509, One Time Strategic Community Investments, under the budget of the Office of Budget and Management (OBM), for grants to certain local entities for one-time strategic investment projects.

#### TANF FY 2025 earmarks

- The bill earmarks an additional \$19.9 million in Fund 3V60 line item 600689, TANF Block Grant, and \$2.5 million in Fund 3V60 line item 830605, TANF Block Grant, in FY 2025. TANF Block Grant funds were appropriated in H.B. 33 of the 135<sup>th</sup> General Assembly.

## State employee pay modification authority

- The bill gives the Director of Administrative Services authority to make temporary changes in pay ranges for state employees not subject to collective bargaining agreements to provide pay parity with state employees who are paid according to terms of collective bargaining agreements. This will likely increase state agency payroll costs in FY 2025.

## Declaration of emergency

- The bill declares an emergency.

## Detailed Analysis

### Capital appropriations and reappropriations

#### Capital appropriations

The bill makes capital appropriations totaling \$3.51 billion for the FY 2025-FY 2026 biennium. LBO's Capital Item Analysis<sup>2</sup> provides summary reports and detailed information on capital appropriations.

#### Capital reappropriations

The bill reappropriates approximately \$1.98 billion in capital funds for the FY 2025-FY 2026 biennium. This amount represents an estimate of available moneys on July 1, 2024. Generally, the actual reappropriations will be equal to the actual moneys available on July 1, 2024. These capital reappropriations are summarized in the two tables below. Table 1 presents the estimated amounts by fund. Table 2 presents the estimated amounts by fund and agency.

## One Time Strategic Community Investments appropriations

The bill appropriates \$717.8 million in FY 2025 from Fund 5AY1 line item 042509, One Time Strategic Community Investments, for the Office of Budget and Management (OBM) to provide grants to certain local entities for one-time strategic investment projects. Under the bill, OBM, prior to disbursing a grant, must enter into a grant agreement with the recipient. As part of the grant agreement, a recipient must agree to complete a final report, in a form and manner to be prescribed by OBM, detailing how the recipient used the grant and submit the report to OBM. The bill reappropriates an amount equal to the available balance of line item 042509 at the end of FY 2025 for the same purpose in FY 2026.

Fund 5AY1 received a transfer of \$700.0 million from the GRF at the beginning of FY 2024 under a provision of H.B. 33 of the 135<sup>th</sup> General Assembly, the main operating appropriations bill. In addition to the H.B. 33 transfer of \$700.0 million, the bill transfers \$17.8 million from the GRF to Fund 5AY1. The bill earmarks the appropriation for the projects listed in Table 3.

## TANF FY 2025 earmarks

Federal Temporary Assistance for Needy Families (TANF) funds were appropriated in H.B. 33 of the 135<sup>th</sup> General Assembly in the following line items: Fund 3V60 line item 600689, TANF Block Grant, under the Ohio Department of Job and Family Services; and Fund 3V60 line item 830605, TANF Block Grant, under the Ohio Department of Children and Youth. There were numerous TANF earmarks to specific entities in FY 2024 and a few earmarks to these same entities in FY 2025. The bill earmarks, in FY 2025, an additional \$19,951,250 in line item 600689 and an additional \$2,500,000 in line item 830605. The additional earmarks in FY 2025 under line item 600689 are as follows (unless otherwise noted, the entity received the same earmark in FY 2024):

- \$10,151,250 to support the mission and goals of the Governor’s Office of Faith-Based and Community Initiatives (\$13,535,000 was earmarked for this purpose in FY 2024);
- \$4,500,000 to College Now;
- \$2,800,000 to Open Doors Academy;
- \$1,000,000 to Child Focus;
- \$500,000 to Best Buddies;
- \$375,000 to the Foundry Row, Sail, Dream Program;
- \$300,000 to Shoes and Clothes for Kids;
- \$200,000 to MY Project USA; and
- \$125,000 to the HEART Food Pantry, Inc.

The additional earmark in FY 2025 in line item 830605 is \$2,500,000 to the Ohio Commission on Fatherhood, which received the same amount in FY 2024.

## State employee pay modification authority

The bill may increase administrative costs for the Department of Administrative Services (DAS) slightly and will likely result in increased payroll costs for state agencies during FY 2025. It authorizes the DAS director to temporarily modify pay ranges in current law to achieve pay parity between state employees who are not subject to the Public Employees’ Collective Bargaining Law and those paid in accordance with a collective bargaining agreement that is effective on or after

March 1, 2024. The bill limits any modification to the pay period that includes July 1, 2024, through the pay period that includes June 30, 2025. The bill requires the Director to report any modification to the Controlling Board.

Statutory pay ranges for employees not subject to collective bargaining are typically established by the General Assembly in parity with pay ranges in the state's collective bargaining agreement with the Ohio Civil Service Employees Association (OCSEA). The state's previous contract with OCSEA expired on February 28, 2024. This agreement was subsequently extended through July 11, 2024 while terms of a new collective bargaining agreement were negotiated. According to OCSEA's June 12, 2024, newsletter, votes to approve a new agreement are to be held by July 5, 2024. Collective bargaining agreements between the state and OCSEA typically have a three-year duration.

## **Public Works Commission provisions**

### **Funding allocations – District Public Works Integrating Committees**

The bill modifies how the 19 district public works integrating committees across the state use their share of funding allocated by PWC under the State Capital Improvement Program (SCIP). Instead of requiring that a minimum of 10% be used for loans or local debt support, as under current law, the bill permits a maximum of 10% be used for either of these two purposes. This may lead districts to distribute more of their SCIP allocations in the form of grants.

The bill makes other related changes that appear to have no fiscal impact. Please see the LSC bill analysis for a full description of these changes.

### **Clean Ohio – open space acquisition using PWC grants**

Finally, the bill eliminates leasing arrangements among the means that local governments, parks districts, conservation districts, and environmental and conservation organizations registered as 501(c)(3)s may use to secure long-term control of real property through Clean Ohio grants under PWC. As a result of this change, grant funding may only be used for purchasing easements, buying property, or making improvements to property previously acquired using Clean Ohio funding as provided under current law.
