This table summarizes how the latest substitute version of the bill differs from the immediately preceding version. It addresses only the topics on which the two versions differ substantively. It does not list topics on which the two bills are substantively the same.

<b>Admission procedures</b>	
Requires each chartered nonpublic school that enrolls EdChoice and Cleveland scholarship students to include in its admission procedure a method to determine which students to admit if the number of applicants for a grade level, school building, or education program exceeds the school's capacity ( <i>R.C. 3301.165(B)</i> ).	No provision.
Requires each school to report its method for admission determinations to the Department of Education and Workforce ( <i>R.C. 3301.165(B)</i> ).	No provision.
<b>Data reporting</b>	
Requires each qualifying chartered nonpublic school to annually report to the Department all of the following: <ol style="list-style-type: none"> <li>The school's total enrollment and its capacity limits by grade level, school building, and education program; and</li> </ol>	Requires the Department to annually post on its publicly accessible website all of the following for each chartered nonpublic school: <ol style="list-style-type: none"> <li>The school's total enrollment;</li> <li>The number of EdChoice, Cleveland, Jon Peterson, and Autism scholarship students enrolled in the school,</li> </ol>

<b>Chartered nonpublic school report card</b>	
Requires the Department to establish a report card for qualifying chartered nonpublic schools ( <i>R.C. 3302.0311</i> ).	Same, but requires the Department to establish the report card for <i>all</i> chartered nonpublic schools and to consult with its state advisory committee on chartered nonpublic schools in establishing that report card ( <i>R.C. 3302.0311</i> ).
Requires the Department to include in the report card issued for a qualifying chartered nonpublic school the school's report regarding its total enrollment and the number of EdChoice and Cleveland scholarship students enrolled in it ( <i>R.C. 3302.0311</i> ).	No provision.
<b>Family income of students receiving an SGO scholarship</b>	
Requires the Department to annually publish on its website aggregate data that includes the family income of each EdChoice scholarship recipient attending a chartered nonpublic school for whom a scholarship from a scholarship granting organization (SGO) is used to pay for remaining tuition and fees ( <i>R.C. 3310.13(F)</i> ).	No provision.
Requires the Department of Education and Workforce to request from the Department of Taxation any data necessary to report aggregate family income data ( <i>R.C. 3310.13(F)</i> ).	No provision.
<b>Confidentiality and liability</b>	
No provision.	Subjects a chartered nonpublic school student's disciplinary record to state student privacy laws in the same manner as a public school student's school record ( <i>R.C. 3313.6612</i> ).
No provision.	Establishes an exemption from liability in damages in a civil action for a chartered nonpublic school or school employee for an injury allegedly arising during the transfer of disciplinary records required by state law ( <i>R.C. 3313.6612</i> ).
