# **Fiscal Note & Local Impact Statement**

**Bill**: S.B. 115 of the 131st G.A. **Date**: April 20, 2015

Status: As Introduced Sponsor: Sens. Bacon and Beagle

Local Impact Statement Procedure Required: No

Contents: To regulate certificates of insurance prepared or issued as evidence of property or casualty

insurance coverage

#### **State Fiscal Highlights**

- The bill may increase the Department of Insurance's administrative costs. If there is any increase in such costs, it would be paid from the Department of Insurance Operating Fund (Fund 5540).
- The bill allows the Superintendent of Insurance to impose penalties. Any penalties collected by the Superintendent may help offset such administrative costs.

#### **Local Fiscal Highlights**

No direct fiscal effect on political subdivisions.

### **Detailed Fiscal Analysis**

The bill provides for certificates of insurance, a document that provides evidence of property and casualty coverage, and regulates the content, preparation, and issuance of such certificates. The bill specifies that a certificate of insurance<sup>1</sup> is not a policy of insurance and a certificate must not be used to confer to any person new or additional rights beyond what the referenced policy of insurance expressly provides.

The bill allows the Superintendent of Insurance to require a person who violates any requirement related to certificates of insurance to cease and desist from the actions constituting the violation or assess a civil penalty not to exceed \$1,000 per violation.<sup>2</sup> All penalties assessed under this bill must be deposited into the Department of Insurance Operating Fund (Fund 5540).

The bill also allows the Superintendent to investigate the activities of any person the Superintendent reasonably believes has engaged in or is engaging in an act or practice prohibited under this bill. The bill permits the Superintendent to adopt necessary rules to implement the requirements in the bill.

#### Fiscal effect

The bill may increase the Department of Insurance's administrative costs due to the regulation of certificates of insurance. If there is any increase in such costs, it would be paid from the Department of Insurance Operating Fund (Fund 5540). The bill also allows the Superintendent of Insurance to impose penalties. Any penalties collected by the Superintendent may help offset such administrative costs.
