BILL SUMMARY

- Retains certain agencies, in accordance with Sunset Review Law, until December 31, 2020.
- Formally abolishes certain agencies that have completed their work.

CONTENT AND OPERATION

Background and overview of Sunset Review Law

Under the Sunset Review Law, if the General Assembly does not renew or transfer an agency¹ within an established time frame, the agency expires by operation of law and the Office of Budget and Management cannot authorize the expenditure of any money for the agency on or after the expiration date. The Sunset Review Law itself also expires unless renewed by the General Assembly.

Since its inception, the Sunset Review Law has operated on a periodic cycle of approximately four years. The Sunset Review Committee² convenes at a time specified

¹ "Agency" generally means any board, commission, committee, or council, or any other similar state public body required to be established pursuant to state statutes for the exercise of any function of state government and to which members are appointed or elected. Certain agencies are exempt from Sunset Review Law. R.C. 101.82, not in the bill.

² The Sunset Review Law creates the Sunset Review Committee (a bipartisan Committee, consisting of three Senate members appointed by the President of the Senate, three House members appointed by the Speaker of the House of Representatives, and three individuals appointed by the Governor with the advice and consent of the Senate) to carry out a periodic review of those state boards, commissions, councils, committees, and other entities to which the Sunset Review Law applies. by law, establishes a schedule for agency review hearings, conducts hearings, and issues a report.

The Sunset Review Committee, the Sunset Review Law, and agencies subject to review by the current Sunset Review Committee expire on December 31, 2016, unless renewed by an act of the General Assembly.³

The current Sunset Review Committee, which has been convened to function during the 131st General Assembly, has not yet issued a final report. But, the Committee has acted officially to make recommendations with respect to the agencies addressed in the bill. The bill indicates the Committee's recommendations to retain the agencies listed below under "**Renewal of specific agencies**" and to abolish the agencies listed below under "**Abolition of specific agencies.**" The bill does not renew the Sunset Review Law and does not provide for a future Sunset Review Committee to be convened.

Renewal of specific agencies

The bill retains the agencies listed below and specifies that they will expire on December 31, 2020, unless future legislation renews them:

- Advisory Committee on Livestock Exhibitions;⁴
- Advisory Council on Amusement Ride Safety;⁵
- Apprenticeship Council;⁶
- Banking Commission;⁷
- Board of Governors of the Commercial Insurance Joint Underwriting Association;⁸
