## CONTENT AND OPERATION

### "Cuyahoga Valley Career Center" license plate

The bill creates the following license plate:<sup>1</sup>

<b>Special License Plate</b>	<b>Cuyahoga Valley Career Center</b> license plate, inscribed with the words and markings selected and designed by the Cuyahoga Valley Career Center and that are approved by the Registrar of Motor Vehicles.
<b>Recipients</b>	Available to all applicants.
<b>Eligible Vehicles</b>	Any passenger car, noncommercial motor vehicle, recreational vehicle, motorcycle, cab-enclosed motorcycle, motor-driven cycle, motor scooter, or other vehicle approved by the Registrar.
<b>Contribution and Additional BMV Fee</b>	\$30 required contribution. \$10 additional administrative BMV fee.
<b>Use of Contribution</b>	Contributions must be used by the Cuyahoga Valley Career Center to provide services to the Career Center's students that assist in developing or maintaining the mental and emotional well-being of the students.  The services may include bereavement counseling, instruction in defensive driving techniques, sensitivity training, and the counseling and education of students regarding bullying, dating violence, drug abuse, suicide prevention, and human trafficking.

	<p>The Career Center may hire charitable (501(c)(3)) organizations to provide services or may pay for faculty members to receive training in providing the services.</p> <p>The Career Center is prohibited from using the contributions it receives for any purpose other than providing the services specified above.<sup>2</sup></p>
<b>Requirements for Issuance</b>	<p>(1) Submission of an application;</p> <p>(2) Payment of the regular license tax, contribution, administrative fee, any applicable local tax, any applicable special reserved license plate fee;</p> <p>(3) Compliance with all other applicable laws relating to motor vehicle registration.</p>
<b>Combined with Special Reserved License Plate</b>	May be combined with a special reserved license plate provided in current law.
<b>Applicability of License Plate Termination Procedures</b>	Procedures governing the termination of nonstandard license plates do not apply. <sup>3</sup>
