BILL SUMMARY

Designations

- Designates 28 new memorial highways, one new bridge, and one new picnic area.

License plates

- Creates 21 new nonstandard license plates and amends two current nonstandard license plates.

* This analysis was prepared before the report of the House Transportation and Public Safety Committee appeared in the House Journal. Note that the list of co-sponsors and the legislative history may be incomplete.

CONTENT AND OPERATION

Designations

The act designates the following highways, a bridge, and a picnic area and authorizes the Director of Transportation to erect suitable markers along the highways and bridges and requires the Chief of the Division of Parks and Watercraft to erect suitable markers in the picnic area:

Poland Township Police Officer Charles K. Yates suffered a fatal heart attack following repeated struggles with a combative female suspect he had arrested for drunk driving.

"Michael J. Nonstandard license plates

The bill creates 19 new nonstandard license plates, all of which are available to the general public. The license plates require the payment of a contribution of varying amounts on license plate issuance or renewal, to be deposited into the existing License Plate Contribution Fund, along with an additional annual \$10 Bureau of Motor Vehicles (BMV) fee. The additional fee must be deposited into the Public Safety – Highway Purposes Fund and used by the BMV for its additional services in issuing the nonstandard plates. All of the new plates require payment of the regular license tax, any local motor vehicle tax, and the appropriate special reserved license plate fee, if required.

Generally, new license plates may be issued for passenger cars, noncommercial motor vehicles, recreational vehicles, and any other vehicle of a class approved by the Registrar of Motor Vehicles. However, under the act, the "Kenston Local Schools" license plate and the "Cuyahoga Valley Career Center" license plate also may be issued for motorcycles, cab-enclosed motorcycles, and any motor-driven cycle or motor scooter.

In addition to the 19 new license plates that require a contribution and payment of a BMV fee, the bill establishes the "Line of Duty Sacrifice" and "Ohio National Guard Ohio Cross" license plates. All 21 of the new license plates are set forth in the following chart, which includes a description of each license plate:

The bill amends the "Juvenile Diabetes Research Foundation" license plate to redirect the contributions received for the nonstandard license plate to the Central Ohio Chapter of the Juvenile Diabetes Research Foundation to distribute the contributions to the various chapters of the Foundation based on the geographic territory of the person who paid the contribution. Current law directs the contributions to each of the various chapters directly from the Registrar of Motor Vehicles.⁷⁴ Additionally, the bill removes operators of commercial motor vehicles as potential applicants for the "Westerville Parks Foundation" license plate.⁷⁵
