SUMMARY

- Appropriates for FY 2021 a total of \$299.9 million for grants to businesses and child care providers impacted by COVID-19, and for local fairs and Ohio Veterans Homes.
- Appropriates for FY 2022 amounts remaining in the Coronavirus Relief Fund at the end of FY 2021.

DETAILED ANALYSIS

FY 2021 appropriations

The bill appropriates money for FY 2021 from various funds, as follows:

Awards must be based on factors such as demonstrated loss of revenue due to cancelled events or performances. 2. \$10 million for \$10,000 relief grants to new businesses opened after January 1, 2020. 3. \$150 million for a small business grant relief program established by Controlling Board action in

Department of Job and Family Services ²	\$112.2 million (Federal Fund Group Fund 3H70)	<p>1. \$44.8 million for grants to child day-care centers and Type A or Type B family day care homes for:</p> <p>a. Ongoing infrastructure costs; and</p> <p>b. PPE purchases and current or previously incurred costs or losses related to smaller class sizes, related to the COVID-19 pandemic.</p> <p>Grants are to be awarded based on the center's or home's capacity to serve children and its Step Up to Quality rating.</p> <p>2. \$67.4 million for stipends to certain child care staff and administrators, retroactive to October 1, 2020. FY 2022 appropriation from Coronavirus Relief Fund

Finally, the bill reappropriates for FY 2022 leftover amounts in the Coronavirus Relief Fund at the end of FY 2021.⁵ This fund contains Ohio's share of federal CARES Act⁶ moneys and must be used for necessary expenditures incurred due to COVID-19.
